## Bedford Rural Electric Cooperative, Inc. Tuition Assistance Application

The Bedford Rural Electric Cooperative, Inc. will provide a minimum \$150.00 tuition assistance award during the Fall and Spring semesters to a student who attends the Bedford County Campus of Allegany College of Maryland and meets the following eligibility requirements. The amount may vary based on availability of funds each semester,

### Eligibility Requirements:

1. Be accepted by Allegany College of Maryland as a regular college student. (Early College students are not eligible to apply.)
2. Be enrolled in college coursework through the Bedford County Campus of Allegany College of Maryland.
3. Have a GPA of 2.5 or higher.
4. Your primary residence must be served by Bedford Rural Electric Cooperative, Inc. or you must be a dependent (pursuant to IRS guidelines) of a parent or guardian whose primary residence is served by the Bedford Rural Electric Cooperative, Inc.
5. Submit the application, along with the most recent copy of your Bedford Rural Electric Cooperative, Inc. bill or your parent's or guardian's electric bill to the following location:
