

## **HEALTH PROFESSIONS PRE-LICENSURE**

#### NURSING ASSISTANT/GERIATRIC AIDE

Certified Nursing Assistants/Geriatric Aides provide basic care to patients under the direct supervision of a nurse. They are able to perform delegated duties in a hospital, doctor's office, nursing home, or assisted living facility. This training consists of classroom and laboratory competency-based modules designed to prepare the student for employment in an acute care or long-term care facility. Many home care agencies also find this certification beneficial.

This course is approved through the Maryland Board of Nursing; successful completion allows the student to apply for certification in MD as a CNA and prepares students to take the National Nurse Aide Assessment Program Exam.

The FOUR (4) courses that make up this certification are Introduction to Health & Wellness, Nursing Assistant/Geriatric Aide Classroom (parts I & II), Nursing Assistant/Geriatric Aide Clinical, and CPR. The total cost, without books or college credit, is \$1,816.00 for Allegany County residents. This includes the cost for the required BLS (Basic Life Support) CPR Certification; however, students must register for this separately by calling 301-784-5341.

# Introduction to Health and Wellness (CHE321)

This course is required for Nursing Assistant/ Geriatric Aide and Pharmacy Technician CE Certificate programs. It includes curriculum goals and objectives, basic concepts needed in health care, and wellness issues for patients and the health care workers. An overview of medical ethics, professional conduct, infection control, medical terminology, communicating with patients, body mechanics, wellness, proper eating habits, principles of fitness, stress and time management, and teaching patient awareness of healthy lifestyle options to enhance recovery and their everyday life will also be discussed. In order to meet Nursing Assistant and Pharmacy Technician requirements, students must achieve a grade of "C" or better.

This is the SAME course offered as part of the credit Nursing Assistant Curriculum and Pharmacy Technician Programs; however, no college credit is received, nor is traditional financial aid available.

She will review your results and assist you in registering for the CNA/GNA course or to set up remediation training if needed.

#### Nursing Assistant/Geriatric Aide Certification Training (CHE322/CHE342)

This course is designed to provide students with the classroom theory and clinical skills essential in assisting nurses in delivering proper basic bedside care of patients across the life span. This program offers a broad foundation of knowledge and skills for the Certified Nursing Assistant and the Geriatric Nursing Assistant. Successful completion of the course qualifies the student to apply for Maryland certification and to sit for the National Nurse Aide Assessment examination. Graduates will be able to seek employment in a variety of health care settings. Course work emphasizes growth and development throughout the life span, basic personal care, vital signs, communication and interpersonal skills, nutrition, medical asepsis, legal and ethical responsibilities, safe and efficient work practices, and medical terminology. In order to successfully pass this course, students must achieve a grade of "C" or better along with meeting the academic standards of the college. Students must also demonstrate successful achievement on a standardized test assessing reading. Please see page 46 for required testing details. Instructor consent required to take this course. This is the SAME course offered as part of the credit Nursing Assistant curriculum; however, no college credit is received, nor is traditional financial aid available. # PHARMACY TECHNICIAN CERTIFICATION

This course will cover knowledge areas and skills required and tested on the registry exam for the state of Maryland. Students will learn about drug classifications, generic and name brands, dosage calculations, and state and federal laws regarding working in a pharmacy. The student will work with analytical balances and compounding equipment that will prepare them for clinical application. A variety of measurement systems will be covered in the course, as the student will need to be able to apply conversions properly. In order to successfully pass this course, students must achieve a grade of "C" or better, along with meeting the academic standards of the college. Instructor consent required to take this course. The courses that make up this certification are Introduction to Health & Wellness, Pharmacy Technician 101 (parts I & II)), Pharmacy Technician 102 Internship Lecture, Pharmacy Technician Internship clinical (parts I, II & III) and CPR. #### **Medicine Aide Update** (CHE433)

Due to the relatively inexpensive manual cupping equipment used, ACE Massage Cupping is a great starting point for health professionals. Learn basic techniques for safe and innovative therapies that achieve amazing results and do not leave marks! This workshop includes theory and applications, with plenty of hands on activity to practice. You will also leave with new assessment skills that become fundamental to customizing the work for each person you treat.

# Two-part Dental Professionals Course (CHE792)

# Part One: Forensic Dentistry for the Dental Professional

Forensic dentistry, or forensic odontology, applies dental expertise to legal investigations, specifically in identifying human remains via dental records and analyzing bite marks. It also involves offering expert testimony in court cases. During this presentation, participants will appreciate how forensic dentistry is instrumental in dental identification, addressing cases involving trauma, abuse, and mass fatality incidents. Practical examples showcasing forensic dentistry's application will underscore the importance of sharing this knowledge among practitioners in Maryland.

#### Speaker Bio:

Patrick A. Murray, DDS, FAAFS

Dr. Murray graduated from the University of Notre Dame and the University of Maryland Dental School. His dental career began with a four year tour in the U.S. Army, and remaining years in private dental practice. Along the way, and post 9-11, Dr. Murray joined a Federal Disaster Team (DMORT Region 3) and served for eight years as the Training Officer of DMORT Region 3. In addition to private dental practice in Rockville, MD for thirty seven years (sold in 2021), Dr. Murray is currently the Chief Forensic Odontologist for the Office of the Chief Medical Examiner (OCME) in Baltimore, MD. At the present time, Dr. Murray is working for Correctional Dental Associates at the Maryland Correctional Facilities in Hagerstown, MD. He is a Fellow in the American Academy of Forensic Sciences and has presented at several Academy meetings in the past.



# Part Two: Balance in the Chair: Mindful Techniques for Dental Professionals

Dental professionals and their patients have stress in their lives and many patients experience additional anxiety surrounding dental appointments.

This course will provide an overview of the biological underpinnings of Mind-Body Medicine and through experiential activity and role play, practical strategies for dental professionals to manage their own stress and create a calm and supportive environment for their patients.

- Describe the mind-body connection and its impact on overall well-being.
- Implement practical techniques for stress reduction, including mindfulness, deep breathing exercises, and progressive muscle relaxation.
- Employ mind-body tools to manage patient anxiety in the dental office.

ACLS (CPR769)

#### WHO SHOULD TAKE THIS COURSE?

Healthcare professionals who either direct or participate in the management of cardiopulmonary arrest or other cardiovascular emergencies. This includes personnel in emergency response, emergency medicine, intensive care, and critical care units such as physicians, nurses, and paramedics.

#### **COURSE COVERS:**

- Basic life support skills, including effective chest compressions, use of a bag-mask device, and use of an AED
- Recognition and early management of respiratory and cardiac arrest
- Recognition and early management of periarrest conditions such as symptomatic bradycardia
- Airway management
- Related pharmacology
- Management of ACS and stroke
- Effective communication as a member and leader of a resuscitation team

Successful course completion includes demonstrating skills competency in all learning stations and passing the CPR and AED skills test, bag-mask ventilation skills test, a Megacode test and a written test. Upon successful completion, students received an ACLS Provider eCard, valid for two years.

**Prerequisite:** Current BLS (Basic Life Support) Provider CPR completion card, second year clinical Allied Health student or permission of instructor.

After completing the program, students will be prepared to take the national and state certification tests to obtain their National Registered Paramedic (NRP) and Maryland Paramedic certifications.

#### TRAINING FOR THE LAYPERSON

The ACM Training Center is committed to a standard of excellence in the teaching and training of the general public in the fundamentals of basic CPR and First Aid. An individual's survival and subsequent recovery from a heart attack or a serious accident is often directly related to the quality of care immediately provided by a family member or person(s) on the scene. The ACM Training Center will provide the highest caliber of instruction to those individuals preparing for the time when they may be called upon to act.

**Heartsaver First Aid and Adult CPR (with optional Child CPR AED and Infant CPR)** (CPR101) According to the Occupational Safety and Health Administration (OSHA), approximately 4 million injuries and illnesses occur annually in the workplace, and nearly 80 percent of sudden cardiac arrests occur outside the hospital.

Heartsaver First Aid CPR AED is a classroom, video-based, instructor-led course that teaches students critical skills needed to respond to and manage a first aid, choking or sudden cardiac arrest emergency in the first few minutes until emergency medical services (EMS) arrives. In this course, students learn skills such as how to treat bleeding, sprains, broken bones, shock and other first aid emergencies. This course also teaches adult CPR and AED use.

Upon successful completion of the course, including a first aid, CPR and AED skills test, students receive a Heartsaver First Aid CPR AED course completion card, valid for 2 years.

**Audience:** All lay rescuers, including childcare workers, babysitters, firefighters, police, airline personnel, security guards, or family members of patients at high risk for cardiac arrest. *This course meets OSHA standards for First Aid.* 

**Prerequisites:** None. This course is specifically designed for the lay person so students are not expected to know any of the material or have related experience. The cost of registration includes a workbook. This workbook will be provided during your class time.

Note: Class end times may vary based upon the number of students, student skill level, and need/desire for Child/Infant CPR training. Classes may be cancelled due to low enrollment.

# **Basic Life Support (BLS) Provider** (CPR775)

The Basic Life Support (BLS) Provider Course is a video-based, Instructor-led course that teaches both single-rescuer and team basic life support skills for application in both prehospital and in-facility environments, with a focus on high-quality CPR and team dynamics. This course trains participants to promptly recognize several life-threatening emergencies, give high-quality chest compressions, deliver appropriate ventilations and provide early use of an AED.

BLS Provider teaches skills using the American Heart Association's proven Practice-While-Watching technique, which allows Instructors to observe students, provide feedback and guide students' acquisition of skills.

Upon successful completion of the course, including a CPR and AED skills test and a written test, students receive a BLS Provider course completion card, valid for 2 years.

**Audience:** Physicians, nurses, paramedics, EMT's, respiratory, physical & occupational therapists, physician assistants, residents, medical/nursing students, aides, and other allied health personnel and lifeguards that choose to pursue this important credential for personal and/or work-related reasons.

**Prerequisites:** None. This course is recommended for the professional healthcare provider. The cost of registration includes the cost of the workbook which students will receive at the beginning of class.

# **Basic Life Support (BLS) Provider RENEWAL** (CPR776)

The AHA has added a BLS Renewal Course option for BLS providers to complete BLS training and receive a BLS Provider course completion card. The BLS Renewal Course is a video-based, Instructor Led Training course that features accelerated content. It is designed specifically for providers with a current BLS Provider course completion card and allows for time efficiency while teaching both single-rescuer and team basic life support skills in both in-facility and prehospital settings.

<u>Prerequisites:</u> Students must present their current (OR within 30 Days of Expiration) BLS Provider card to the instructor upon arrival to the class. The instructor maintains the right to dismiss a student that does not present a valid BLS Provider card.

#### Stigma and Practice Impact through an Ethics Lens (DHR766)

Attention to factors which stigmatize clients from the perspectives of society, providers of care, and impacted individuals, is crucial to ethical human services practice. Recent events have demonstrated that bias against people with different national and religious beliefs is growing. Preconceptions about individuals with physical and mental disabilities has been wielded in the political arena to the detriment of many of the consumers that social workers serve. This workshop will examine both personally mediated and societally based origins of stigma which impact many individuals presenting for services as well as the systems that keep stigma alive and well. In this workshop, we will identify and discuss sources of internal bias and point of view, including the media, and their impact on clients and on providers. We will also explore the impact of recent events on the perpetuation of stigma and how we can act to address this. We will then discuss in detail the nine commonly identified dimensions of stigma and the challenges clinicians face in ethically addressing these dimensions individually and collectively. The challenges faced by stigmatized individuals and groups in accessing and remaining engaged in care will be discussed in depth. Strategies for providers of care to assist in remaining vigilant to emerging stigma in practice will be discussed.


