LINDA BUCKEL JOINS ALLEGANY COLLEGE OF MARYLAND'S BOARD OF TRUSTEES

CUMBERLAND, Md. (Aug. 2, 2018) – Linda Buckel, Esq., senior partner with Buckel, Levasseur & Pillai, LLC, has been named to the board of trustees of Allegany College of Maryland (ACM).

With strong ties to ACM—as an alumnae, a former adjunct professor, Office Technologies/Paralegal Program Advisory Committee member, and Joseph P. Rowley Memorial Scholarship donor—Buckel brings a wealth of experience to the college's seven-member, governor-appointed board.

She attended ACM part-time from 1975-1979. A resident of LaVale, she serves on the Trial Courts Judicial Nominating Commission for District 5, Allegany and Garrett Counties, and is a member of the Frostburg Soroptimist Club and the Midlothian Trinity Assembly of God.

Buckel was appointed to fill a trustee vacancy created after James J. Ortiz concluded his participation -more-
