HEALTH & SAFETY INFORMATION

- Safety/Security: Allegany College of Maryland takes the safety of its students, employees, and campus visitors seriously. We respond to every report and act swiftly to promote a secure learning environment. Please contact Campus Safety/Special Police (301) 784-5555 to report an unsafe incident or condition, if you have questions or concerns about safety or if you have information about a crime or conduct violation. Always call 911 in an emergency. We encourage all students to register for E-Safe, an emergency alert system that is free; the College's website has an icon you click to sign up. *Please do NOT leave your valuables unattended. Make sure your wallets, purses, phones, laptops, tablets, books, and anything else of value are either in your possession or safely locked up.
- See Something/Say Something: If you have information about misconduct, crimes, policy violations, or other matters of serious concern, please contact the appropriate ACM official to share this information, so the College can respond and take necessary steps. While direct reports are the best way to help ACM intervene, the College also provides a reporting hotline for students and employees to anonymously report illegal or unethical activity. Reports can be made to 877-690-0002 or www.lighthouse-services.com/allegany. (Regular business issues and matters not requiring anonymity should still be directed to the designated College official.)
- Crime Statistics and Annual Report: Allegany College of Maryland's most recent crime and fire report can be found online at https://allegany.edu/documents-policies/index.html. We are proud of having very low numbers at ACM!
- Code of Student Conduct: all credit students are expected to behave responsibly. All students should report any acts of misconduct promptly. The Code of Student Conduct details both behavior standards and procedure if you are the subject of disciplinary action. The Code of Student Conduct applies ON-CAMPUS AND OFF-CAMPUS. If you are accused of misconduct, the victim of misconduct, or a witness to misconduct, you will receive a Notice via student email; be sure to read the email and follow all directions. - Title IX / Sexual Harassment & Sex Discrimination: Allegany College of Maryland has a strict policy about sexual harassment and sex discrimination by or against all students, employees, and campus guests. These acts are strictly prohibited: sexual assault, relationship violence, stalking, sexual harassment, and gender-based discrimination. The College also does not permit retaliation against any person who reports violations or cooperates with investigations. All students are expected to conduct themselves appropriately at all times and to do nothing to endanger the safety or wellbeing of other students, employees, and campus visitors. Develop healthy relationships (violence is never okay!) and make sure you have consent for any intimate act (No means NO; you would be wise to get a YES before doing anything!) If you have any questions or concerns or if you need to make a complaint, contact ACM's Title IX Coordinator, Dr. Renee Conner in CC-12, by email at mailegany.edu, or by phone at (301) 784-5206. - Alcohol, Drugs, Smoking: ACM is a DRY, CLEAN, and CLEAR campus. That means alcohol, illicit drugs, and smoking/tobacco are prohibited. It also means no person is permitted to be on campus under the influence of alcohol or drugs. Any student who is suspected of being impaired or in possession of alcohol/drugs faces immediate evaluation for safety and disciplinary action. Smoking any smoking and tobacco use strictly prohibited on all campus property including buildings, parking lots, vehicles, and fields/lawns. E-cigarettes and vaping are included in the College's policy. The College's Alcohol & Drug Policy details what is permitted, what is not permitted, and the disciplinary consequences for violations which could also be crimes prosecuted in court. Do not risk your education! Also be aware that drug/alcohol violations can jeopardize your financial aid.
 - **All new students are <u>required</u> to complete an educational module about heroin and opioids, follow the details and directions already sent to your student email.

POLICY & SERVICES REMINDERS

- FERPA: The Family Educational Rights Privacy Act applies to all students and, in a nutshell, means your ACM records are private, and we don't discuss student information with anyone unless the student has signed a FERPA Release or a legal exception applies. Even with a signed release, College Officials may only discuss your college information with YOU. Details are in the FERPA policy found here https://www.allegany.edu/legal-information/index.html
- **Equity**: ACM prohibits unlawful discrimination. No employee is permitted to engage in discriminatory behavior or practices. *Also be aware that the Code of Student Conduct prohibits hate crimes and hate bias incidents.

- 1. Hate Crime: an offense that manifests evidence that the victim was intentionally selected because of the perpetrator's bias against the victim on the basis of race, religion, sexual orientation, gender, gender identity, ethnicity, national origin, or disability.
- 2. Hate-Bias Incident: a hostile act of conduct, speech, or expression motivated in whole or in part by intolerance, bias, or prejudice against another. Unlike a hate crime, the hostile act is not a criminal act; like a hate crime, the hostile act is motivated by prejudice.

The most recent Diversity Report is also online. We encourage all students to embrace the principles of equity and non-discrimination, too!

Our policy highlights how persons can exercise their speech and expressive rights with reasonable time, place, and manner restrictions free from discrimination or unconstitutional content-based restrictions by the institution. - **Student email**: Student Communication Policy requires students to regularly monitor their student email account, and all college business must be conducted on college email. The policy also prohibits any other person from accessing or using your student email
